- 3. Reports:

- w. Property (Guil Lake) the rest of the gravel has been delivered and someone already made a mess of it the same day.
  - Steve is lining up to install gates next Saturday.
  - fencing is required and Steve would like help coming up with a list of materials so that we can then get a quote on the cost. 4 ¼ inch by 6 foot fence posts, bought in a bundle was recommended.
  - signs need to be made.
  - littering is still happening. Steve cleaned up another mattress among other items.
  - 2 fire pits have been donated by Brice Heidt.
  - the camp kitchen concrete is still good. Not cracked or broke!
  - We need someone to do a design plan so that we can get quotes for the toilets for all of our facilities.
